Deryl Gregory – Deryl Gregory reported the following:

- Deryl reported there is a blood drive on the 19th at the church hall from 4-7
- January 21st KoC is hosting a free throw competition and registration is at noon. This will be the first of four of these. Any age up to 16.
- He and Deb went and did the court audit on Monday and that went well.

Debra Grogan – Debra Grogan reported the following

- Debra reported her and Deryl went to the senior housing party and had a great time.
- Debbie attended the Ellenburg Center Fire Department Christmas party and the town was recognized for the EMS. There were many awards given at the party.
- Debbie attended the windmill meeting. Landowners are going to be compensated for the loss of windmills on their land. AES is looking at GE windmills. Invenergy said that the county is still negotiating the PILOT, and the application will be ready in January. Marie is down in NYC meeting with the governor soon about the windmills. The battery storage law, Eric, our attorney is doing research on that now. Jason asked if we were going to re-negotiate the HOST agreement with AES, Debbie stated she would discuss this with them. The battery storage is so new that there is not a lot of information to base it off of.

Neil Trombley – Neil Trombley reported the following:

- Neil reported he has been working with Shannon on planning. Working on swimming grants and we are back in with the Highway garage if there is a generator that becomes available.
 - Jason stated that we are going to make a "building reserve fund" at the beginning of 2024 to be able to spend funds on things that we need for daily operation.

• Looks like we could be getting anywhere up to \$600,000 from FEMA for the flooding.
